# Museum of Deaf History Arts & Culture (MDHAC) PRIVACY POLICY

#### **Information You Provide**

MDHAC collects personal information from you when you engage in online or in person transactions such as purchases, registrations, making a donation or becoming a Friends of MDHAC member. Additionally, personal information may be transmitted as part of a form submission or in connection with other internal programs, activities, services, or resources available on our website.

For example, we collect personal information **on our website** when you:

- Create an account
- Purchase tickets or registration fees
- Purchase a membership
- Make a donation
- Purchase merchandise
- Purchase or redeem a gift membership
- Fill out a "Contact Us" request
- Subscribe to a mailing list
- Participate in certain programs (for example, when you complete an online application or program request)
- Communicate with use through the website, including completion of online forms

In addition, we may collect personal information **outside our website** via:

- In person ticket or membership sales
- By phone
- On-Site (for example during an event, a visitor may choose to complete a form and hand it to a staff member, for example in connection with membership or subscription)

- Returning mail to us, such as membership renewal solicitations
- Completing a survey mailed to you
- · Completing contact information on forms at local events

#### **How Personal Information is Used**

The information that we collect in person and online is used solely for contact with the individual who has given us their personal information or for the original purpose of the given information. MDHAC uses the personal information that you provide us for internal purposes only. We do **not** share, lend, or sell any personal information of our supporters and website users to other individuals or organizations for commercial or any other purposes.

We may use personal information to contact you to provide information about other activities, programs, membership and fundraising opportunities, products and special events that may interest you. You may opt-out of having your information used by MDHAC for these purposes, or you may update your contact information anytime, by contacting us via the form on our Contact Us web page.

MDHAC engages third-party vendors in order to help us process online and offline transactions, better respond to the needs of our visitors, and enhance our marketing efforts. This includes third-party analytics vendors such as Google Analytics who serve advertisements across the Internet, offline, and sometimes on other websites on the Deaf Museum's behalf. They may use information about your visits to the website and other sites to personalize advertisements for goods and services.

MDHAC may use or disclose your personal information if required to do so by law or in the good-faith belief that such action is necessary to (a) conform to applicable law or comply with legal process served on the MDHAC; (b) protect and defend the MDHAC's rights or property, the website, or the MDHAC's users; and (c) act under emergency circumstances to protect the

personal safety of the Deaf Museum affiliates, agents, or the users of the website or the public.

#### Cookies

The Deaf Museum's website uses cookies to distinguish you from other users, provide a better experience when you browse our website, and improve our site's performance and usefulness. By continuing to browse the site, you are agreeing to our use of cookies.

A cookie is a small data file that websites can place on your hard drive when you visit. A cookie file can contain information such as a user ID that tracks the pages you've visited within that site. The cookies on this website are primarily used to recognize that a user has visited the website previously and to track user traffic patterns. Third parties, including Facebook, may use cookies, web beacons, and other storage technologies to collect or receive information from our website and elsewhere on the internet and use that information to provide measurement services and target ads.

#### Children

MDHAC does not knowingly collect personal information directly from children under thirteen years of age. Children should always ask parents/ guardians for permission before providing personal information to any website or purchasing any products or services online. #### Personal Data
